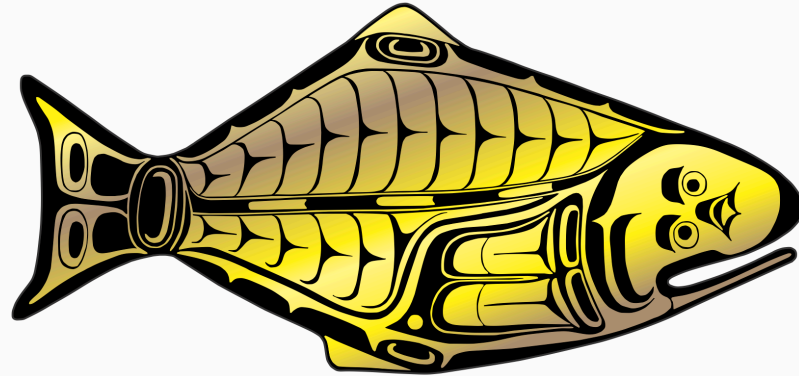
Recommendations
