PURPOSE

To provide the Commission with an opportunity to consider the regulatory proposals received from the IPHC Secretariat, agencies, and stakeholders for 2017.

BACKGROUND

Each year, the Commission accepts regulatory proposals from stakeholders, agencies, and the IPHC Secretariat. Regulatory proposals are accepted through 31 October each year. At the Commission's Interim Meeting, the Commission reviews the draft regulatory proposals received and asks for clarification from and/or provides initial feedback to proposal authors.
