Halibut Avoidance Practices

Fishing target choice, location, time of day Small test tows when entering an area Excluders Vessel to vessel communication Weekly bycatch conference calls Deck sorting -Quickly return halibut to the water All Amendment 80 vessels authorized to participate

2015 Council Halibut Action

Reduction of Amendment 80 cooperative cap by 25% (581 mt)

Directed Amendment 80 cooperatives to develop halibut avoidance plans

- define avoidance practices
- assess performance
- create reduction incentives

Halibut Avoidance Plan

<u>Goal</u>

"...ensure that Amendment 80 vessels use the best available operational practices to avoid halibut and reduce halibut mortality."

Plan is agreed to by all Amendment 80 vessels



Vessels must meet halibut rate standard (kg hal/mt gf) <u>Annual standard</u> in each target <u>Fourth quarter standard</u> in targets combined Monetary penalties - \$25,000-\$100,000 per violation

<u>Quarterly monitoring</u> applies to vessels failing an annual test in the following year Halibut limit forfeitures

<u>Annual test – Eliminate Outliers</u>

Eliminate outliers in flatfish targets based on historical rates (kg halibut/mt of groundfish)

Vessels must achieve rates based on historical average fleet performance

<u>Yellowfin sole</u> – 2016 - 11.7 2017 - 10.2

<u>Rock sole</u> – 2016 - 14.3 2017 - 12.6

<u>Flathead sole/Arrowtooth flounder</u> – 2016 - 21.0 2017 - 19.2

<u>Annual tests – Eliminate Outliers</u>

Retrospective analysis (2008-2015)

4 vessels on average failed to meet the 2016 standards

Average annual fines would total over \$250,000

2016 results

All vessels met 2016 standard in all fisheries One vessel failed to meet the 2017 standard in one fishery

Fourth quarter test

Maintains incentive for avoidance through year end

Applies an aggregate rate standard to all flatfish targets - 12.1 kg halibut/mt groundfish

Fourth quarter test

Retrospective analysis (2008-2015)

5 vessels on average failed to meet the standard each year

Average annual fines would total over \$140,000

2016 results

All vessels met 2016 standard in all fisheries
