### 2015 HALIBUT LANDING REPORT NO. 4

## Area 2A Non-Treaty Directed Commercial Halibut Fishery Closed for Remainder of 2015

The International Pacific Halibut Commission reports that the total catch limit for the Area 2A non-treaty directed commercial fishery has been reached following the July 8 fishing period. As a result, the Area 2A non-treaty directed commercial fishery is closed for the remainder of 2015.

### Area 2A Incidental Commercial Halibut Fishery During the Salmon Troll Season

The total allowable incidental commercial catch of halibut allocated to the Area 2A salmon troll fishery is 29,035 pounds. Incidental catch of halibut in the salmon troll fishery was allowed beginning April 1. It is estimated that 15,900 pounds have been landed through July 12 in Washington and Oregon, leaving 13,135 pounds to be harvested. The incidental halibut catch fishery during the salmon troll season remains open until further notice. # <u>Area 2A Incidental Commercial Halibut Fishery During the Limited Entry, Fixed Gear Sablefish Fishery</u>

The total allowable incidental commercial catch of halibut allocated to the limited entry, fixed gear sablefish fishery, which operates in Area 2A north of Point Chehalis, Washington, is 10,347 pounds. Incidental catch of halibut in the sablefish fishery was allowed beginning April 1. It is estimated that 6,600 pounds have been landed through June 24, leaving 3,747 pounds to be harvested. The incidental commercial halibut fishery during the limited entry, fixed gear sablefish fishery remains open until further notice. # Annette Islands Reserve Fishery in Area 2C

The Metlakatla Indian Community has been authorized by the United States Government to conduct a commercial halibut fishery within the Annette Islands Reserve. Four 48-hour fishing periods, with opening dates of April 24, May 8, May 22, and June 5, had halibut catches of 2,371, 6,592, 5,679, and 7,200 pounds, respectively. The total landed weight of halibut to date during the 2015 season is 21,842 pounds. The Metlakatla Indian Community and the Bureau of Indian Affairs will announce future halibut openings.

### Quota Share Commercial Fisheries Update

The 2015 quota share halibut fisheries opened on March 14. It is estimated that the following commercial landings, in pounds and numbers, were made in the Alaskan IFQ fishery through July 13, 2015 and in the British Columbian IVQ fishery through July 10, 2015.

The catch off Alaska represents 55% of the 2015 commercial fishery catch limit. For comparison, 9.4 million pounds, or 56% of the 2014 catch limit, were landed in the Alaskan fishery by this same date in 2014; however, the opening date of the 2014 fishery occurred six days earlier in the year than that of the 2015 fishery. Thus, during the first 121 days of the 2014 Alaskan commercial halibut fishery, 9.1 million pounds, or 54% of the catch limit, were landed.

The catch from British Columbian (Area 2B) waters represents 58% of the 2015 commercial fishery catch limit. For comparison, 3.1 million pounds, or 53% of the 2014 catch limit, had been landed from Area 2B by this same date in 2014. Also, during the first 118 days of the 2014 IVQ fishery, 3.0 million pounds, or 52% of the catch limit, had been landed.
