## **HALIBUT COMMISSION ANNOUNCES 2016 CATCH LIMITS AND SEASONS**

The International Pacific Halibut Commission (IPHC) completed its Ninety-second Annual Meeting in Juneau, AK on January 29, 2016. More than 280 halibut industry stakeholders attended the meeting, with over 80 more participating in web broadcasts of the public sessions.

The Commission is recommending to the governments of Canada and the United States catch limits for 2016 totaling 29.89 million pounds, displayed in the following table by regulatory area.

The Commission approved a season of **March 19 – November 7, 2016** for the U.S. and Canadian Individual Quota fisheries. The Treaty tribal commercial fisheries and the incidental halibut fisheries in Area 2A will occur within these dates. In Area 2A, eight 10-hour fishing periods for the non-treaty directed commercial fishery are recommended: June 22, July 6, July 20, August 3, August 17, August 31, September 14, and September 28, 2016.

A subsequent IPHC News Release will provide more details of the Annual Meeting, including the regulatory and other issues decided by the Commission.
